- 2. Consider allowing a second Grade 9 student to accompany you and your child to work that day.
- 3. Talk to your friends and colleagues about this day and its opportunities for them to become involved.
- **4.** Encourage your place of employment to endorse this program and to consider offering an invitation not just to Grade 9 children of employees but to other Grade 9 students who could benefit from the experience.
